Share capital information and voting rights

On 8 October 2014, the last practicable date prior to the publication of the Notice of AGM, the issued share capital of Smiths Group plc comprised solely of 394,676,028 ordinary shares of 37.5p each nominal value ('ordinary shares'), all of which have been admitted to the Official List of the FCA and admitted to trading on the London Stock Exchange.

Each ordinary share has one vote on a poll. It is intended that the resolutions proposed at the AGM will be subject to voting by poll.

Smiths Group plc does not hold any shares in treasury.

Therefore, the total number of voting rights in Smiths Group plc on 8 October 2014 was 394,676,028.

In order to be entitled to attend and vote at the AGM or any adjourned meeting (and for the purpose of the determination by the Company of the votes they may cast), shareholders must be registered in the register of members of the Company at 6.00pm on 16 November 2014 (or, in the event of any adjournment, 6.00pm on the date which is two days before the time of the reconvening of the adjourned meeting). Changes to the register of members after the relevant deadline shall be disregarded in determining the rights of any person to attend and vote at the meeting. Any share issued and allotted after the relevant deadline shall be disregarded for the purpose of determining voting rights at the meeting. The total number of voting rights which shall be capable of being exercised at the AGM shall be the number of ordinary shares in issue at 6.00pm on 16 November 2014 (or the relevant deadline in the event of any adjournment.)
